CERTIFICATE OF INSURANCE AND ADDITIONAL INSURED ENDORSEMENT

A Certificate of Insurance and additional Insured Endorsement will be required for events/activity.

The Certification of Insurance and an Additional Insured Endorsement should include a description of your event and the following:

“Use of facilities during the policy year for special events for which the County of Tuolumne and Tuolumne Parks and Recreation District is named as additional insured during the policy year as respects to written contract with the insured.”
