2. Set up times are Friday at 2:30 pm and Saturday at 9:00 am. **NO EARLY SET UP AVAILABLE.**
3. No illegal items may be sold. Alcohol is prohibited.
4. The Tuolumne Park and recreation district will in no way be responsible for lost, stolen, misplaced or damaged merchandise or injury of vendors before, during, or after the sale.
5. Fees: \$15.00 per site for one day (\$25.00 for both days) must be received prior to set up. Space is 10x10. If vendor needs more than that, there will be an additional charge.
6. Food vendors are required to submit a copy of their Health Department permit with this agreement. No food sales will be allowed without a permit.
7. Removal of all trash and other items are the responsibility of the vendor.
